NOTED that the Chairman and Clerk are to attend a meeting later in the month with neighbouring parish councils to discuss how councils can work together. c) Football pitch at the playing field – a request from West Felton Football Club to turn the playing field into an 11 aside football pitch (involving the relocation of play equipment) was considered. **RESOLVED** that in principle the Council is positive with the idea, but could not move forward without some control over the adjacent land for relocating the play equipment and the football club securing funding for the project. 69.24 **PARISH PROJECTS/ISSUES** a) Tree Preservation Orders – arboriculturalist quotes for tree health surveys and amenity value surveys for priority areas agreed at July council meeting were considered and RESOLVED to approve. Cllr Jones abstained from the vote for item 69.24(a). b) Parking near the shop – members considered whether to request Shropshire Council to put in double yellow lines and have Local Enforcement Officers patrolling to improve safety at the Cross junction, as recommended by the police. **RESOLVED** to take no further action except for Cllr Grove speaking informally with the shop owner to request that he ask delivery lorries to offload on the Avenue. Cllr D'Arcy left the meeting for item 69.24(b). c) The Punch Bowl – members considered what steps could be taken to help secure the future of The Punch Bowl and its car park for the community. **RESOLVED** to delegate power to the Clerk to apply for the Punch Bowl and car park to become registered as an Asset of Community Value. d) Neighbourhood Plan – RESOLVED to defer a decision on progressing this until the November meeting. 70.24 **NEXT MEETING** It was NOTED that the next meeting of the Parish Council will be held on Tuesday 8 October 2024 at
